Mayor Cheney invited Kent Graham to address the Board. Kent indicated that he owns the following rentals 100-102 Main & 109-113 Main, in addition to his home within the Village. He is here this evening to ensure that the Village Board and Employees are on the same page as he, per his emails. Joe and Billy questioned Kent with regard to the accuracy of the documented violations at 100-102 Main, to which Kent explained that he was in the process of repairing the gutters on his building and that there are currently renovations consisting of painting, ceiling tile replacement etc being completed; this should have been evident to Ben from the pile of lumber on the property. Joe pointed out that the presence of lumber would indicate un-permitted construction in process. Kent reiterated that he was very upset to receive a violation notice by mail instead of a telephone call regarding the same, he also did not appreciate Code Enforcement Officer Ben Wheat coming onto his property unaccompanied. In addition, he feels that there is a conflict of interest between one of his tenants and the Village. Jim explained the Village's position on both of these issues and indicated that Code Enforcement would attempt to call prior to any inspections. The Village cannot promise he will always call, in an emergency Code Enforcement needs to respond immediately to determine if there really is an emergency. Per visual exterior inspection of the property today, it was noted that the gutter issue has been addressed with discharge into the Village sewer system, Kent acknowledged that this is unacceptable and will address.
