Mayor Cheney opened the meeting with the pledge of allegiance to the flag at 5:00 pm.

REPORTS:

DPW, WWTP & Water:

- 1. DPW October report No questions regarding Josh's provided report. Jim indicated that Josh would be addressing sidewalks in the spring. Briefly discussed NYS DOT's response to our 30 MPH street paintings.
- 2. WWTP October report No questions. Adam indicated that he and Pete removed a lot of old stored paint etc from the plant area, SDS sheets printed for remaining "hazards".
- 3. Lead Line Replacement Program Notification document formulated; Michael is working on manipulating the inventory excel sheet to create mailing labels for the 11/15 deadline.

 <u>Water@phelpsny.com</u> is now functioning for the return of information.

Police:

- 1. October reports no questions. Jim thanked John for the police participation at the Halloween events. John indicated that, even with the additional patrols, there were two near misses, of kids crossing on Main Street, he would like to suggest some type of glow sticks being provided by YPR.
- 2. November schedule no questions.

Fire Department:

- 1. October reports No questions. Aaron indicated that 2121 (2008 Pierce Engine) \$13,000 \$15,000 repairs are nearing completion, this is currently our newest engine and has been out of service for 4 weeks.
- New Fire Truck Conversation the assembled Fire Department members offered information regarding the current apparatus and the safety of the community. Homeowners fire insurance is determined by the score of your local FD, Phelps is at a 6 out of 10 which could be better resulting in reduced residents' premiums; we are shy of the 3,000 gallons per minute by 1,000 gallons. The proposed new truck would address this. 2171 (1996 Pierce Rescue) was refurbished to gain an additional 10 years to save money for a new engine. The new engine would replace 2131 (2004 Pierce Engine), 2131 was recently out of service briefly due to a starter issue, this left the FD relying on mutual aid exclusively. 2141 (1999 Mack Tanker) meets its need and 2151 (2007 Ford Brush) would be the next to be replaced behind 2131. Mayor Cheney questioned whether the FD membership is sufficient to roll all the apparatus, Aaron indicated that we have enough active members that this is not an issue within our department. Aaron will update the apparatus replacement schedule for the Board. The more than million-dollar price for an appropriate, standard, no frills, engine is only going to keep increasing; if we get it ordered now, the 2004 Pierce Engine retains its trade in value of \$75,000 to \$100,000. The Board thanks the members for their input, wants to insure we are being fiscally responsible; Jill to pull Brandon's initial paperwork from the October meeting, confirm reserve amounts/pricing and make a decision at the December meeting. Brandon to provide Jill with bid specs as well.

Fire Department Members left the meeting at 5:58 pm.

8 Banta Street:

WHEREAS, the project to be included in the application will be a redevelopment of the Phelps Hotel, located at 90 Main Street, Phelps, NY 14532, which will renovate the vacant 19,000 square foot property into a mixed-use building containing a restaurant and bar/speakeasy on the first floor and basement and up to 8 residential units on the upper floors; and

WHEREAS, the Village recognizes that this project is a priority project that will contribute to the renewal of this downtown area, strengthen the local economy, and increase the quality of life for residents; and

WHEREAS, the Village has worked with the property owner/developer to ensure that this project is aligned with local development plans and is seeking ways to find funding avenues to complete this project with public and private funds; and

WHEREAS, the funding is a 10% minimum equity match grant program and the Village is working with the relevant property owners to meet that match requirement;

WHEREAS, this project is consistent with all existing local plans, the proposed financing is appropriate for the project, the project will facilitate effective and efficient use of existing and future public resources so as to promote both economic development and preservation of community resources, and the project develops and enhances infrastructure and/or other facilities in a manner that will attract, create and sustain employment opportunities in Phelps; and

NOW THEREFORE BE IT RESOLVED that the Village Board hereby supports and will sponsor an application for Restore NY funding for the property at 90 Main Street and will administer the grant in accordance with all applicable rules and regulations established by ESDC; and

BE IT FURTHER RESOLVED that the Village of Phelps supports this Restore NY application submission and the \$250 application fee that is required for the application; and

BE IT FURTHER RESOLVED that the Mayor is authorized to sign the application and any agreements required by ESDC for grant funding that results from the application.
